**a) 57<sup>th</sup> Annual General Meeting**

The 57<sup>th</sup> Annual General Meeting of the Company ("AGM") is scheduled to be held on **Monday, 29<sup>th</sup> September, 2025 at 11:30 a.m. through Video Conferencing ("VC")/Other Audio Video Means ("OAVM")** at the Registered Office of the Company at 26-27, Mumbai Pune Road, Pimpri, Pune - 411018, in accordance with the applicable circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India to transact the business of the Company as mentioned in the Notice to be issued in this regard.

**b) Remote E-Voting for the 57<sup>th</sup> AGM**

The Company is pleased to provide to the Members with the facility to exercise their right to vote during the AGM by electronic means and the business thereat may be transacted through e-Voting Services provided by NSDL. In terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management & Administration) Rules, 2014, the cut-off date has been fixed as Monday, 22<sup>nd</sup> September, 2025 for determining eligibility of Members to vote by remote e-voting or by e-voting at the AGM.

The remote e-voting period commences on Friday, 26<sup>th</sup> September, 2025 at 9:00 A.M. and will end on Sunday, 28<sup>th</sup> September, 2025 at 5:00 P.M. The remote e-voting module shall be disabled thereafter by NSDL with whom the Company is entering into an agreement to facilitate the members to exercise their right to vote by remote e-voting. ### **c) Payment of Dividend**

As informed earlier, the Board of Directors at its meeting held on 28<sup>th</sup> May, 2025 had recommended payment of dividend of 400 % (Rs. 8/- per equity share) for the financial year ended 31<sup>st</sup> March 2025 (2024-25), subject to the approval of the Members at the said AGM.
